The reservation form for the Elks National Convention which will be held in Atlanta Georgia July 3rd through July 6th, 2022 **is on side B of this letter.** The Grand Lodge Convention Commission has assigned the New England delegation to the Elks National Convention to the *Atlanta Marriott Marquis Hotel, 265 Peachtree Center Avenue - Atlanta, Georgia 30303*

We are presenting a five-night package, arriving on Saturday, July 2nd and departing on Thursday, July 7th. Limited additional days are available at either end of our package; rate and accommodations are based upon availability.

Rooms will be assigned on a first-come/first-serve basis. I urge you to send your reservations in as early as possible, but **no later than April 30, 2022.** You must send the reservation with **full payment.** **Reservations received without full payment or payments received without a reservation will be returned.** **Late applications will not assure you a room in the New England Elks Headquarters Hotel.**

If a Lodge is unsure of who their Exalted Ruler will be, the Lodge may send a reservation with the full payment in the name of the Lodge, clearly indicating that it is for the Exalted Ruler-Elect and then send the appropriate name and information required **as soon as it is available.** This will ensure that your Lodge receives a room at the New England Headquarters Hotel.
